3. It is the school's responsibility to ensure that any electronic files are used by students, parents and personnel from the school only.
4. It is the school's responsibility to ensure their teachers understand and comply with these Terms and Conditions.
5. Under the terms of this Agreement, in accordance with the *Copyright Act 1968* (Part VB), neither the school nor any teachers within the school are authorised to:
  - (a) store or post files or links to these files in publicly available or non-secure electronic environments
  - (b) share, sell or hire out the electronic files or copies of the electronic files with a third party (individual or school)
  - (c) alter, edit or reformat any of the files.
6. This licence is valid for one school calendar year. Any saved or printed materials from iMaths Online may only be used during the purchased year of access (school calendar year).
